Liability Waiver:

Fee Adjustments and Notifications

I understand that Marion Country Club reserves the right to adjust membership fees and dues. Any changes to fees will be communicated to members in writing, either by mail to the last known address or by email, with a minimum of 30 days' notice before the new rates take effect. Membership will continue at the adjusted rate unless canceled by the member in accordance with the club's cancellation policy.

Membership Approval

All applications for membership at Marion Country Club are subject to approval by club management. Marion Country Club reserves the right to accept or refuse membership applications at its discretion for any reason. Submission of this application does not guarantee membership.

Membership Term and Cancellation Policy

Membership at Marion Country Club is continuous and remains active until canceled by the member or club. Dues are billed monthly via ACH, and the membership will automatically continue on this basis. Members may cancel at any time by providing written notice at least 15 days before the next billing cycle. No refunds will be given for partial months. The club reserves the right to terminate memberships at any time, with or without cause, by providing written notice. If a canceled member wishes to rejoin the club, they will be subject to the \$500 initiation fee upon re-enrollment.

Member Code of Conduct:

All members and guests are expected to conduct themselves respectfully and adhere to club rules and guidelines. Marion Country Club reserves the right to revoke membership privileges for actions inconsistent with club policies.

Photo/Video Release:
