6. Rules & Regulations

Access & Season Passes

- Public Swim Days: The pool is open to the public on Sundays and Tuesdays.
- Private Swim Days: In addition to Sundays and Tuesdays, the pool is available for Members and Season Pass Holders on Mondays, Wednesdays, Thursdays, Fridays, and Saturdays.
- Check-In Required: All visitors, both members and public guests, must check in at the Snack Shack upon arrival.

General Rules

- Age Requirement: Children **under 14 years of age** must be accompanied by an adult at all times.
- Food & Beverages: No outside food or drinks are allowed. Concessions are available at the Snack Shack.
- Pool Safety:
 - No running, rough play, or diving in shallow areas.
 - Proper swim attire is required.
 - No glass containers are permitted in the pool area.
- No smoking or vaping in or around pool.
- Respect & Conduct:
 - Be courteous and respectful to fellow swimmers and staff.
 - Disruptive behavior may result in removal from the facility.

7. Liability Waiver

By signing below, I acknowledge and agree that Marion Country Club, LLC, its employees, and affiliates are not responsible for any accidents, injuries, or damages that may occur while I or my household members are using the club's facilities.
